In Memoriam: Barry J. Nace (1944 – 2021)



Dear NBTA Members,

Yesterday our friend, colleague, and former President Barry Nace passed away. A gifted trial lawyer, Barry played a key role in the NBTA. He earned his NBTA board certification in Civil Trial Advocacy in 1997, encouraged many others to do the same and was elected to serve on the NBTA Board of Directors in 2001. For the rest of his life, Barry was periodically reelected to the Board of Directors. He served as the NBTA President, with distinction, from 2006 to 2008. Barry also served as a Founding Director of the NBTA Foundation.

Barry was well known for his volunteer and charitable work, which included decades of service with ATLA/AAJ, where he served as president from 1993-1994. Linda Lipsen, CEO of the AAJ, wrote yesterday: "When Barry served as AAJ President, he ushered in a new grassroots approach to advocacy on Capitol Hill. During his presidency, AAJ was able to beat back a massive products liability bill that would have made it impossible for clients to be compensated for their injuries. The grassroots approach was so effective that the bill was never again considered by Congress. I vividly remember this time because Barry hired me during that year." She added: "For Barry's distinguished service in advancing AAJ's mission and growth, plus his outstanding contributions to trial advocacy in a career that has spanned more than 40 years, he received the Leonard M. Ring Champion of Justice Award in 2020."

Our Executive Director Melissa Sternbach mentioned that when Barry joined our Board he did so as the representative of the renowned International Academy of Trial Lawyers and noted: "he was a big proponent for keeping ATLA (AAJ now) and NBTA in collaborations." Roger Daily, another member of the NBTA full-time staff, added "Barry's tenure as NBTA President saw a stabilization of the organization's financials through administrative reorganization and through board and member initiatives which led to budget surpluses."

Barry was a stellar lawyer, advocate, and very special human being. He was larger than life and not only could be counted upon he was also a caring, and decisive man. He sized up a problem and cut to the chase. Barry clearly loved the NBTA, as we all know, and we loved Barry. We are saddened by the enormity of this loss.
